### **Approval of February Commission on Aging Meeting Minutes**

#### **Presentations and Discussion:**

##### **1. Senior Housing Workgroup report**

**Alan Ormsby** gave an update on the recently formed Senior Housing Workgroup. The first meetings have been well attended and discussions have been productive. The workgroup is currently formulating an area of focus.

##### **2. Utah State Geographic Information Database**

**Bert Granberg**, Manager, Utah's State Geographic Information Database

Bert gave a PowerPoint presentation entitled "*A Location-Based Approach to Service Planning*". He explained the goals and scope of AGRC which does digital mapping for the State of Utah. The Geographic Information Systems/Software (GIS) gives the ability to model the world's infrastructure. The website is [www.gis.utah.gov](http://www.gis.utah.gov)

The AGRC have been in existence since 1984 to maintain the State geographic Database. It has access to 400 layers of information. This tool provides a way to query info with multiple variables. The Utah AFRC website provides many Aging related geographic statistics and features such as: Community, Housing, Employment, healthcare facilities, transportation, fitness, entertainment, security, representation and other individual factors, such as faith and family related topics Bert would be interested in adding more to this list in regards to the Aging population and will appreciate the Commission member's feedback. They are working on using census information to collect data, as well as commercial data sets.

##### **3. ePOLST**

**Becky Kapp** Electronic Physician Order for Life Sustaining Treatment (ePOLST) program status.

Becky reported that Droid and Apple apps are available for ePOLST. Everyone is being encouraged to use ePOLST. Medicare/Medicaid are requiring that healthcare providers get the ePOLST filled, signed and on file.
